Turf Conversion

- Single family home residents can receive \$1 a square foot, up to \$2,000 per project for converting grass lawns to desert-friendly landscaping.
- Commercial/Large Landscape customers can receive up to \$25,000 per project.

Must be pre-approved. Not retro-active.

Residential turf removed: 2,300,000 sq ft.

Commercial/ HOA turf removed: 4,300,000 sq ft

Total of 6,600,000 sq ft of turf grass. **Around 152 acres.**

Smart Irrigation Controllers

Residential Customers:

Smart controllers and installation are currently no charge.

Commercial/HOA:

Rebate 50% of cost of controllers, evaluated on a case-by-case basis.



Up to 30% savings in water for people who don't regularly change their irrigation clock schedules. How often should you change?

Customer's with the most turf grass will benefit the most. Old clock must be currently working and cannot be hard-wired.

Important to remember clock is not like regular clocks so proper adjustments are very important.

New Generation Rotary Nozzles

- Residential and Commercial rebates for new generation rotary nozzles, up to \$4 per nozzle.
- Residential: \$2000 max = 500 nozzles.
- Commercial/HOA: \$10,000 max = 2500 nozzles.
- Hunter, Rain Bird, Toro, K-Rain



- Multi-trajectory nozzles apply water to lawns in finger-like streams and are more resistant to wind.
- It applies water slower allowing water to soak into the soil for a more even distribution. Less runoff because water has time to soak into the soil.
- Up to 30% more efficient but depends on proper water schedules.

Toilet Rebates

- Residents can receive a **rebate for up to \$100** for installing a high-efficiency toilets rated at **1.28 gpf** or less.
(maximum two per home)
- Commercial establishments can receive a rebate of up to one-half the cost of each toilet and installation up to a total cost of \$280 per toilet. **Max rebate up to \$140 per toilet.** New toilets must be rated a **1.28 gpf** or less.



- To qualify for a residential toilet rebate, the old toilets must use 3gpf or more or installed prior to 1992. Homes built after 1992 already have a 1.6 gpf toilet and considered efficient.
- Old toilets need to be recycled at Desert Recycling.
- Dual flush toilets are ok. Typically rated at 1.1/1.6
- Commercial: Old toilets have to be rated at 1.6 or more to qualify.

Residential Indoor Conservation Kits

Indoor Water Conservation Kits are free: Go to CVWD.org and click on the Conservation section and go to Rebates and Discounts to fill out the online application.



Some supplies in office.
One per single family residence.
Must have an account with CVWD.

Pre-Rinse Nozzles & Water Brooms for Commercial Customers

Pre-rinse nozzles and water broom sets will be distributed free to restaurants, schools and other commercial, institutional or industrial customers.



- **High efficiency pre-rinse nozzles** use less than 1 GPM compared to traditional pre-rinse nozzles that consume approx. 2-5 GPM and will typically clean an item in 20 seconds.
- **Water brooms** use approx. 2 GPM compared to traditional hose and spray nozzle which uses up to approx. 8-12 GPM.
- Approved for businesses that need to clean for health purposes. Not just to replace a brooms.
- Restaurants, Pet Stores, Pools where food and beverages are served etc... (Limit 1 broom for business. 1 per 20 pools for HOA's)
